3. Field Day 2022 was discussed and the plan to set up as a SINGLE station at the Grand River Riverfront Park in Lowell was discussed. The involved dates will be June 24, 25, 26, 2022. Nathan Hardman (N8THN) will check on the necessary permit documents and fees.
